NIH continues to prepare for data management and sharing policy implementation in 2023

- A new blog post from the NIH Office of Science Policy announced the release of a new set
 of <u>FAQs</u> about the DMS policy and asked for public comments on the draft <u>Supplemental</u>
 <u>Information to the NIH Policy for Data Management and Sharing: Responsible Management and
 Sharing of American Indian/ Alaska Native Participant Data</u>. They plan to release many more
 resources to help researchers with effective data management and sharing throughout 2022,
