We are excited to introduce a new resource: [Writing READMEs for research code & software](#), with an accompanying [readme template for software](#) to adapt and use to document your code and software. A readme file can be used to provide information and context about data, code, or software and is intended to help ensure that the files can be correctly interpreted and used, by yourself at a later date or by others when data is shared or published. Our general [guide to writing “readme” style metadata](#) and the accompanying [readme template for data](#) has been one of the most highly visited and downloaded resources on the CDS website, so we are happy to offer guidance customized for code and software.
